Educators Work Group

Made recommendations to secure permanent funding in the Governor's budget for Redding items that were originally funded as one-time allocations:

- The Redding Consortium requests that the Governor include in his proposed operating budget a \$720,000 line item for a multi-year package that consists of focused partnerships with Institutes of Higher Education to provide coaching for administrators and educators in high needs schools in Wilmington, driven by teacher surveys and collaborative school leadership, to improve school climate and build cultures of respect to ultimately limit teacher attrition.
- The Redding Consortium requests that the Governor include in his proposed operating budget a \$100,000 line item for tuition assistance geared towards recruiting and obtaining certification for education professionals, community members, parents, and other working adults representative of the students and families in high needs schools within the city of Wilmington. Working adults in the community would be recommended by leaders or peers and given financial assistance to attend certification programs offered at institutions and organizations such as University of Delaware, Delaware State University, Relay Delaware, Wilmington University, and Delaware Technical Community College.
