Redding Consortium Work Overview Senator Lockman and Matt Denn, Redding Co-Chairs

• In 2022, (Fiscal Year '23), the Redding Consortium secured 12.8M in funding, with 10.2M in the operating budget. All the funds are targeted towards policies and practices that work towards educational equity.

• In 2021, (Fiscal Year '22), the Redding Consortium secured \$10.2M in funding.
